The safety and security of our community should always be the number one priority.

Like many California communities, the Town of Apple Valley has faced significant financial challenges in recent years, with repeated budget deficits threatening the essential services we rely on daily. Those deficits are expected to increase and continue in the coming years. Law enforcement and public safety, in particular, are at risk if we do not secure additional funding.

The proposed 1-cent sales tax increase on the upcoming November ballot is crucial in addressing these financial shortfalls. This measure will generate approximately \$9 million annually, all remaining within our community to support critical town services.

This funding will help maintain quick 911 response times, ensure the hiring and retention of Sheriff's deputies, and enhance our ability to respond effectively to property crimes, thefts, and burglaries. It will also contribute to safe routes to schools, repair our streets and potholes, and support efforts to address homelessness, as well as other town services.

Without this measure, the Town may be forced to make cuts that could jeopardize its ability to effectively protect you and your loved ones. The proposed sales tax is a small price to pay for the safety and well-being of our community. By voting YES, you invest in a safer, more vital Apple Valley.

Let's continue to work together to ensure our town remains a safe place to live, work, and raise our families. I strongly urge you to support this measure for the future of our community. Thank you for your consideration and support.


