

VOTE “NO!” ON MEASURE I!

If Fontana Unified School District’s Bond Measure I passes, **the cost to you** (taxpayers/parents/voters) will aggregately be **\$750 million** in principal and interest over 29 years!! You will pay \$150-\$600 additional on your property tax bill each year, totaling \$4,350-\$17,400, based on your property’s assessed value!

Not paying this additional property tax each year could result in a tax lien being placed on your property. Your property could eventually be a “forced sale” to pay the tax lien--you could lose your home or property!

Parents/residents/taxpayers of the Fontana Unified School District have experienced an **average yearly cost of living increase of \$10,000** over the last 3 years partly from imposed tax increases by government agencies!

- There is **no transparency or accountability!** The “citizen oversight committee” is not independent but selected and chosen by the Fontana School Board.

Fontana Unified School District’s annual budget is 36% higher than the total budget of the city of Fontana! The district needs to more effectively utilize its existing \$667,000,000 annual monies and keep its hands out of the residents/taxpayers’ pockets!
