## **Voting Instructions**

## **Marking your Official Ballot**

- 1. Use only **Blue** or **Black** pen or marker to completely fill in the oval voting target to the left of your choice like this: DO NOT USE RED INK.
- 2. To vote on the measure, completely fill in the oval voting target to the left of the word "YES" or "NO".
- 3. If you make a mistake or damage your ballot, request a replacement ballot.

## **Assistance for Voters with Disabilities**

The Registrar of Voters provides a number of services to increase access and encourage participation by voters with disabilities. Contact the Registrar of Voters office at (909) 387-8300 or (800) 881-VOTE for assistance.

The Registrar of Voters office has an accessible path of travel, accessible parking and includes the following resources:

- Accessible ballot marking devices, including audio and large text options

Additionally, you may bring one or two persons to assist you with marking your ballot.

## **MEASURE U**

#### **IMPARTIAL ANALYSIS OF MEASURE U**

This Impartial Analysis of Measure U has been prepared by County Counsel pursuant to Section 9313 of the California Elections Code.

This Measure was placed on the ballot by a resolution adopted by the Board of Directors of the Bear Valley Community Healthcare District (District). A "yes" vote by at least two-thirds of the voters voting on this Measure will authorize the District to levy an annual special tax on each taxable parcel or real property within the District for ten years, beginning July 1, 2025. A "no" vote means that the District will not levy the special tax.

The District's Resolution No. 25-479 was adopted pursuant to Government Code sections 53720-53730.02. The Measure will impose a special tax of \$40.00 per parcel that is levied annually, commencing on July 1, 2025, and it shall continue for ten years. The special tax is estimated to provide \$1.2 million dollars annually to the District. The tax imposed by this Measure shall be a special tax upon all unimproved and improved parcels of real property in the District and will not be measured by the value of the property.

Beginning July 1, 2025, the special tax will be collected by San Bernardino County on behalf of the District at the same time other charges and taxes are collected. The District will create a designated account into which the proceeds of the tax will be deposited. The District Chief Financial Officer shall file with the Board of Directors of the District an annual report accounting for the tax collected and the way it was spent.

#### ARGUMENT IN FAVOR OF MEASURE U

This Argument in Favor of Measure U was submitted pursuant to Section 9315 of the California Elections Code. It is the opinion of the author(s), and has been printed exactly as submitted.

Last November, Bear Valley voters overwhelmingly supported **Bear Valley Community Hospital** when they decisively approved **Measure U** with 72.15% support. Later, a technicality in state law was discovered, requiring the same tax rate for all parcels, thus making it necessary to return to voters with a **"replacement measure"** that is fully compliant with state law.

Measure U, the hospital's "replacement measure" on the June ballot, is vital to our mountain community quality of life and absolutely deserves your support.

Remember: Bear Valley Community Hospital is the ONLY ER on the mountain for victims of heart attacks, strokes and other emergencies. The next full service hospital is over an hour away

<u>This ISN'T a new tax</u>. **Measure U** simply asks you to authorize **REPLACING** the hospital's existing parcel tax with a flat, \$40 tax for all parcels.

Measure U is absolutely needed and continues to be a sound investment – <u>especially if you care about access</u> to **LIFE-SAVING** emergency medical care in our mountain community.

FACT: Bear Valley Community Hospital is the ONLY ER in Big Bear Valley for victims of heart attacks, strokes and other emergencies. The next full service hospital is nearly an hour away.

VOTING YES LOWERS the Hospital's tax rate for 82% of local property owners.

**Historical FACTS:** Big Bear Valley voters overwhelmingly approved similar hospital measures in 1994, 2003, 2014 and 2024. However, after the November 2024 measure was approved by more than 72%, an angry combatant filed a law suit. Later, the parties **agreed** that current state laws require a uniform tax rate where all property owners gets taxed the same, whether their parcels are "improved" or "unimproved." The Hospital also agreed **not to levy** the tax voters had approved last November. Instead, **Replacement Measure U** now seeks your support to authorize the same (uniform) payment from all property owners required by state law.

Again, <u>Replacement Measure U LOWERS the hospital tax rate for 82% of local property owners</u>. Without Measure U, emergency services, ER physicians, the stroke program, and others services could be cut or eliminated.

Big Bear can easily be cut off from outside help during earthquakes, fires, or other disasters. We NEED a full-service Hospital so LOCAL residents can receive medical care during emergencies like these.

#### **FULL TEXT FOR MEASURE U**

The following is the full proposition presented to the voters by the Bear Valley Community Healthcare District (BVCHD).

To maintain local access to advanced, life-saving emergency medical care, keep medical technology and equipment up-to-date, and ensure Bear Valley Community Hospital has enough qualified doctors and nurses; shall Bear Valley Community Healthcare District's measure be adopted replacing its expiring parcel tax at a rate of \$40 per parcel, providing \$1.2 million dollars annually for 10 years, with independent audits, no money for administrators, and all funds dedicated to Bear Valley Community Hospital services?

#### **SECTION 1: KEY FACTS**

The Bear Valley Community Healthcare District is committed to insuring strong, high-quality healthcare to the Big Bear Valley population and visitors to the Valley.

- The measure presented is a renewal of a parcel tax first approved by voters in 1994. It was subsequently extended by voters in 2003 and 2014.
- Since its inception in 1994, the tax has not been increased.
- The measure generates \$1.2 million that is integral to the hospital operations, community safety, health, and wellness.
- The proposed renewal would assess \$40 per parcel uniformly across the District.
- The funds generated from the measure will be put in a segregated account to be used only for voterapproved purposes and will be subject to an annual report on the receipt and use of the funds that will be available to the public.
- Funds generated from the measure will go towards:
  - 1. Maintaining access to state-of-the-art medical technologies and equipment, including those used in the treatment of victims of accidents/strokes/heart attacks.
  - 2. Retaining qualified nurses and physicians at Bear Valley Community Hospital.
- Funds generated from the measure will not go towards administrator salaries.

#### SUMMARY

Rural health care facilities experience heightened financial challenges amid persisting workforce shortages, rising costs and leveling reimbursement. (Becker's Hospital Review, March 21, 2024.)

Bear Valley Community Healthcare District, which operates a rural, critical access hospital (one of 37 in California) and in July, celebrated its 50<sup>th</sup> year serving the Big Bear Valley Community, is not exception. Revenue from special tax proceeds for the last 31 years have allowed the District to meet the challenges of rising costs for labor and technology, including recruiting and retaining high-quality physicians, specialists, and nurses.

Due to fires, snowstorms, earthquakes and other hazards and natural disasters, the continued operation of BVCHD with a skilled physicians, nurses, and modern equipment and technology, ensures the quality of life and well-being of Big Bear Valley residents. Through continued financial stewardship, the District has allowed for no increase to the parcel tax in its 30-year existence, but it remains a vital financial component of operating critical healthcare services for the community.

#### **How to Vote Your Ballot**

- 1. Read the instructions on the ballot and vote the ballot.
- 2. Refold the ballot exactly as you received it.
- 3. Place the ballot in the enclosed Official Return Envelope and seal it.
- 4. Read the Declaration of Voter on the Official Return Envelope.
- 5. Sign your name by the red "X" and print the date.

#### **How to Return Your Ballot**

- 1. Return by mail:
  - No postage required.
  - Ballot must be postmarked on or before Election Day, June 24 and received by the Registrar of Voters office no later than Tuesday, July 1.
- 2. Drop off at:

    - o Beginning May 27, Monday to Friday, from 8 a.m. to 5 p.m.
    - o Election Day, June 24, from 7 a.m. to 8 p.m.
