Chino is committed to working closely with our residents and businesses on a plan that benefits all members of our community, protects neighborhoods, and maintains property values.

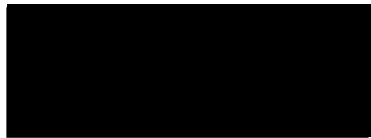
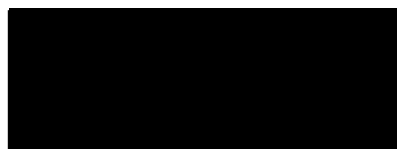
