Why repeal the tax?

- The tax largely falls on residents living in the poorest parts of the county.
- Many of the taxed parcels are vacant land. Cal-Fire is responsible to fight those fires, not the County Fire Protection District.
- Small single-dweller properties pay the same as large luxury hotels.
- Despite widespread disapproval, the FP5 special tax was championed by greedy public
 employee unions and passed by elected county supervisors. A two-thirds approval vote,
 as required by the State Constitution of every voter in the fire district was never even
 submitted to the voters.

What is the YES on Measure [?] campaign really about? It is about sending a message to elected representatives.

- Lining the pockets of public employee unions with taxpayer's money is unacceptable.
- It is about controlling the ever-increasing funding required to feed the over-generous public employee pension system.
- It is about voters insisting their vote be heard and counted by elected officials.
