Unofficial List of Offices that Will Not Appear on the Ballot

In the case of governing board members of a school or special district, if the number of persons who have filed a Declaration of Candidacy does not exceed the number of governing board members to be elected, each person filing a Declaration of Candidacy will be appointed in lieu of election.

These offices will not appear on the ballot. The persons appointed in this manner begin their terms and serve in the same manner as if they were elected by the voters of the district.
