NOVEMBER 8, 2022, GENERAL ELECTION Special District Appointments in Lieu of Election

Not all contests on the **Offices Up For Election** list appeared on the ballot. In the case of directors of a special district to be elected, if the number of persons who filed a declaration of candidacy did not exceed the number of directors up for election, each person filing a declaration of candidacy was appointed in lieu of election by the San Bernardino County Board of Supervisors. Persons appointed in lieu of election begin their terms and serve as if they were elected by the voters of the district.
