NOVEMBER 5, 2024, GENERAL ELECTION Special Districts Appointments In Lieu of Election

Not all contests on the **Offices Up for Election** list appeared on the ballot. In the case of directors of a special district to be elected, if the number of persons who filed a declaration of candidacy did not exceed the number of directors up for election, each person filing a declaration of candidacy was appointed in lieu of election by the San Bernardino County Board of Supervisors.
